Sub: Transfer of shares to Investor Education and Protection Fund (IEPF) for which dividend has not been claimed for 7 consecutive years

Reference is made on the captioned subject:

In this connection, we request you to claim your dividend(s) before the same is transferred to IEPF established by the Central Government. We had also invited your attention to the provisions of the Companies Act, 2013 and Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, which prescribes that all shares shall be transferred to IEPF in respect of which unpaid or unclaimed dividend is transferred as provided under Section 124 (5) and 124 (6) of the Companies Act, 2013 and rules prescribed there under.
