**Limited Review Report on Unaudited Quarterly and Year-to-date Financial Results of Bombay Oxygen Investments Limited under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended.**

**To the Board of Directors of  
Bombay Oxygen Investments Limited**

1. We have reviewed the accompanying Statement of the unaudited Financial Results of Bombay Oxygen Investments Limited (‘the Company’) for the quarter and nine months ended 31st December, 2022 (‘the Statement’) being submitted by the Company pursuant to the requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended (‘the Listing Regulations’).
2. This Statement, which is the responsibility of the Company’s management and approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 *“Interim Financial Reporting”* (‘Ind AS 34’), prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to express a conclusion on the Statement based on our review.
3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 *“Review of Interim Financial Information Performed by the Independent Auditor of the Entity”* issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of the Company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. We have not performed an audit and accordingly, we do not express an audit opinion.





4. Based on our review conducted and procedure performed as stated in paragraph 3 above, nothing has come to our attention that causes us to believe that the accompanying Statement of unaudited financial results, prepared in accordance with applicable accounting standard specified under section 133 of the Companies Act 2013 as amended, read with relevant rules issued thereunder and other recognised accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended ("the Listing Regulations"), including the manner in which it is to be disclosed, or that it contains any material misstatement.
5. The comparative financial results of the Company for the nine months ended 31<sup>st</sup> December, 2021, included in this Statement had been reviewed by predecessor auditor whose report dated 7<sup>th</sup> February, 2022 has expressed an unmodified conclusion on those Statements. The comparative audited financial results for the financial year ended 31<sup>st</sup> March, 2022 which has been reviewed / audited by the predecessor auditor vide its report 23<sup>rd</sup> May, 2022 respectively in which the predecessor auditor has expressed an unmodified conclusion. These reports have been relied upon by AMS & CO. for the purpose of the review of the statement. Our conclusion is not modified in respect of this matter.
